Dear Community Member,

You are receiving this letter because you and/or your organization have exhibited at the Annual Earth Day Fair that is sponsored by the Montgomery Township Environmental Commission and Sustainable Montgomery.

For the April 2016 event, we will sponsor an Earth Day Recycling Fair that will provide collections for recycling common (computers, TVs) and unusual (Brita filters, Halloween costumes) items. In order to accomplish this new emphasis, we hope that your organization will participate.

Here are a few things to consider:

1. The event will be held on Sunday, April 17, 2016, Noon-3 PM, at a local park.
2. Tables, chairs, buckets, etc. (if needed) will be the responsibility of your organization.
3. Your organization will select the item(s) you wish to recycle and then dispose of them. For example, the EC collected pantyhose a few years ago, packaged the donations, and sent them to No Nonsense that recycles them.
4. Adding an educational component to your collection will be optional but encouraged. For example, if you know how your recycled items will be used, you might wish to mount a display indicating their "lifecycle."
5. The EC/SM will continue to organize the collection of metals, electronics, shredded paper and medications.
